2. Minutes

The objective of the 1st meeting in Ostrava (CVIV) is to exchange ideas and examples of good practice among project partners.

Project meeting working atmosphere was built on respect through understanding and working the same direction.

Partners and their teams work in adult education and they have competences and / or possibilities to use intellectual outcomes according project application form.

Differences:

In some countries target groups are different.

Cyprus – seniors

Czech Republic – persons with hearing impairments

Greece – adult mental retardation – music teacher

Lithuania – TAU/AMS – seniors / visual disability (music teachers, language teachers)

Adult educator group was not clarified in details for O2.

The aim of the first meeting in Ostrava, CVIV, is to exchange ideas and examples of artistic exercises among project partners. Coordinator Aldona Vilkeliene described project aim - to develop core competences through music (rhythm, timbre, dynamic, music listening).

All partners show the same philosophy towards project implementation: combining behavioural and existential, social constructive psychological and philosophical background.

All countries gave a short presentation focused on their institutions and national context.

Coordinator, Aldona Vilkeliene presented project aims and possible questions about our similarities and differences. We have common practise working with adult, but we have different target groups (seniors, mentally disabled, hearing impaired visually disabled). It was decided that our differences will be combined and it will be considering as originality of each partner. We will be able to achieve project aims even we prove it from different perspectives, of course, in a frame of the project.

Cyprus partner said that we must follow project parametres with the project participants as a target group.

Practical part: Partners presented their 1st intellectual output (1st version O, 1st level).

Lithuania – Alytus music school

Artistic exercises

Partner gave reflection and expressed their opinion about activity "Myself and music instruments", "Colours as an approach in adult music training".

The video material was commented by music teacher. IPads and smart phones with the colourful keys were used in a group practically.

Kostas from Cyprus told that it would be useful to base it on the theory of colours.

Eduardas (Third Age University) presented two AE about teaching English language through music.

These exercises were developed to their target groups of seniors.

Cyprus – AE (video record) was based on national composer Stelios Pisis. Seniors were listening to his biography, music and painted expressions and emotions. This exercise was to strengthen seniors' national identity. He proposed to read Rolo May "Cry for Myth about my Greece". Panagiotis Korfoxyliotis (Greece) presented three exercises (Melody, Rhythm and Timbre).

Dr. Joanis Makris from Greece participated via Skype and answered questions.

Czech Republic (host organisation) presented three AE for O1 (Metro – level 1, Rondo – level 2, Chains – level 3). The target group was hearing impaired persons.

They presented a movie about theatre performance presented by deaf performers.

This video confirmed an impact and proved it use. We watched an interview that it is used with hearing impaired people. They say that rhythmical exercises helped them to communicate in their everyday life. All level exercises were discussed and all possible ways for optimizing were foreseen.
